As per the Subject and Reference cited above, the Deans/Principal of the affiliated colleges of Homeopathy faculty are hereby instructed to complete the Enrollments and Eligibility of the U.G. and P.G students admitted in the academic session 2015 -16 is hereby extended upto 15<sup>th</sup> June 2016.

Note:-

- 1- Application forms can be downloaded from the MPMSU website [www.mpmsu.edu.in](http://www.mpmsu.edu.in) by clicking in the download forum.
- 2- It is clearly instructed that the fees/ late fees (As per the University Ordinance no. 3 related to fee of Students) from the students shall be collected by the Colleges/Institute and transferred to the University by making a single Demand Draft drawn in favor of " Registrar, M.P. Medical Science University, Jabalpur (M.P.)
- 3- It shall be responsibility of the Dean/Principal of the College/Institution to complete the process of the enrolments of the students admitted to the institute as per the Statute/ ordinance of the University.
- 4- It shall be the responsibility of the Dean/Principal of the College/Institution to ensure that no student is admitted after the cut-off-date declared by the concerned Competent Authority/Apex Council. The enrolment and eligibility shall not be granted by the University to such students, if any, admitted after the cut-off-date.
- 5- The Dean/Principal of the college/Institution must sent the prescribed application forms duly filled in duplicate (2 sets) along with the soft copy of form, documents and fee submission receipt/UTR No./Journal No. should be submitted in person to the Registrar office, Madhya Pradesh Medical Science University, Jabalpur, Madhya Pradesh.
- 6- The Dean/Principal of the college/Institution must send the original documents of the student, along with the professor in charge and a clerk from the student section to expedite the verification of the documents on the specified date as notified by the University separate for your college.
- 7- The Dean/Principal of the College/Institution must send the admitted student list on stamp of 100 rupees stating that all the admitted students are bona fide and fulfill all the criteria as prescribed by the concerned apex council for the batch 2015-2016. All the admission of the students has been done before the cutoff date prescribed by the Apex council or Apex court or any other court.

**Note:** Incomplete form in any respect including fee submission receipt shall not be processed for affiliation and college management shall be solely responsible for the consequences.
